NAME OF BIRDSPRINGS CHAPTER TO TSÍDII TO'II CHAPTER; AMENDING 11  
N.N.C. §10(A)

BE IT ENACTED:

**Section 1. Enactment of the Change of Name from Birdsprings  
Chapter to Tsidii To'ii Chapter**

The Navajo Nation hereby approves the Change of Name from  
Birdsprings Chapter to Tsidii To'ii Chapter.

**Section 2. Codification**


The provisions of this Act which delete or amend sections  
of the Navajo Nation Code shall be codified by the Office of  
Legislative Counsel. The Office of Legislative Counsel shall  
incorporate such provisions in the next codification of the  
Navajo Nation Code.

**Section 3. Savings Clause**

If any provisions of this Act are determined invalid by the  
Navajo Nation Supreme Court, or the District Courts of the  
Navajo Nation without appeal to the Navajo Nation Supreme Court,  
the portions of this Act which are not determined invalid shall  
remain the law of the Navajo Nation.



BIRDSPRINGS CHAPTER TO THE NAVAJO OF TSIDI TO'II.**

**WHEREAS:**

1. Pursuant to 26 N.N.C., Section 3 (A) The Birdsprings Chapter is duly recognized certified chapter of the Navajo Nation Government, as listed at 11 N.N.C. part 1, section 10, and
2. Pursuant to 26 N.N.C., Section 1 (B) Birdsprings Chapter is vested with the authority to review all matters affecting the community to make appropriate Correction when necessary and make recommendation to the Navajo Nation and other local agencies for appropriate actions, and
3. Birdsprings Chapter was recognized as a chapter in 1975 and is a unit of local government which are political subdivision of the Navajo Nation; and the chapter maintains activities on behalf of the community membership, and
4. To further promote, protect and preserve the interest and general welfare including the safety of its community, the Birdsprings Chapter wishes to change the English name to the Navajo name of Tsidi To'ii, and
5. The Birdsprings Chapter hereby requests the Transportation and Community Development Committee, the Budget and Finance Committee, the Division of Community Development and the Capital Improvement Office to see the attached information to prioritize funding projects to incorporate into the overall Navajo Nation Capital Improvement Plan.

The Birdsprings Chapter hereby approves and wishes to change the English name of the Birdsprings community to the Navajo name of Tsidi To'ii.


