22ND NAVAJO NATION COUNCIL - Fourth Year, 2014

AN ACT

RELATING TO LAW AND ORDER, NAABIK'ÍYÁTI' AND NAVAJO NATION
COUNCIL; AMENDING 2 N.N.C. §603 MEETING DATES OF THE LAW AND
ORDER COMMITTEE

BE IT ENACTED:

Section One. Findings and Purpose

1. The Law and Order Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. §600 *et seq.*

2. Oversight authority of the Law and Order Committee includes courts and public safety. 2 N.N.C. §600 *et seq.*

3. The Law and Order Committee meets every Monday. 2 N.N.C. §603. An amendment is necessary to change this weekly meeting requirement to meetings twice a month.

Section Two. Amending 12 N.N.C. §603

The Navajo Nation Council hereby amends 2 N.N.C. §603 as follows:

"Meetings shall be held on ~~Monday of each week~~ the second, third and fourth Mondays of each month."

Section Three. Effective Date

The amendment enacted herein shall be effective pursuant to 2 N.N.C. §221.

Section Four. Codification


The provisions of this Act which amend or adopt new sections of the Navajo Nation Code shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel shall incorporate such amended provisions in the next codification of the Navajo Nation Code.

Section Five. Savings Clause

Should any provision of this Act be determined invalid by the Navajo Supreme Court, or the District Courts of the Navajo Nation without appeal to the Navajo Nation Supreme Court those provisions of the Act which are not determined invalid shall remain the law of the Nation.
