

SUBJECT: Resolution No. CMY-38-12; Amending Navajo Election Code Regarding School Board Candidate Election Qualification

On June 06, 2012 I vetoed Resolution No. CMY-38-12. On June 27, 2012 a corrected version of the Resolution was presented to the Office of the President for consideration. A memorandum that accompanied the Resolution from Speaker Naize explained the inaccuracy of the initial resolution, therefore rendering it "of no legal effect", and finding the Resolution CMY-38-12 before me for consideration once again.

I issued a memorandum dated June 06, 2012 stating my justification for veto. I asserted that only changing the law to extend term limits of school board would not address the school board vacancies and lack of school board quorum. I challenge the Health, Education, and Human Services Committee (HEHSC) and other appropriate programs and committees to examine the school board vacancy problem and come up with a better solution.

I am pleased and very appreciative that the HEHSC, Election Office, and Department of Dine Education took up the Challenge. The Parties agreed to formulate a joint sub-committee to explore and come up with a better plan to address the school board vacancy problem and examine the lack of interest from the community to participate in these elected positions.

The action of signing into law this Resolution will help fill the vacancies for this election, but the efforts of the joint sub-committee with work to address the long-term solution, and my veto justification.

I appreciate the collaboration of the HEHSC and the other parties to proactively address this matter.



SUBJECT: Title Legislation No. CMY-38-12

Pursuant to 2 N.N.C. § 1005 (C) (10), Legislation CMY-38-12, TITLE: Amending the Navajo Nation Election Code at 11 N.N.C. §§ 6 and 8 by Authorizing Four Terms For School Board Positions and Authorizing School Board Members to Serve on One School Board is being submitted to the Navajo Nation Council, through the Office of the Speaker, within the ten (10) days requirement.

Pursuant to 2 N.N.C. § 1005 (C)(11) The Navajo Nation President has authority to veto legislation with a memorandum to the Speaker with reason(s) for the veto. I will exercise my veto authority to veto Legislation CMY-38-12, with the following justifications:

Resolution CMY-38-12 offers to change the law, by extending elective School Board position to four (4) terms. This is the proposed remedy to the vacancies and lack of school board quorum. I will assert that only changing the law to extend terms will not address the concern. The question that needs to be explored is why is there a lack of interest from citizens of the community to serve on school boards?

Educating our Navajo children is a priority to the Navajo Nation. It is also one of the Nation's biggest challenges, for many reasons. The constant challenge to find funding has turned into the challenge of maintaining current funding. The human resource, recruiting teachers is also an ever challenge because of lack of funding, housing and other matters. However, the one human resource we should not lack is the influence of parents, extended family members, and local community leaders to provide constant encouragement and expectations of our Navajo children to make completing their education a priority for themselves.

Serving on the school boards is a prime opportunity for parents and the communities to provide this local service, influence, and opportunity for their children. I would challenge the Health, Education, and Human Services Committee and all appropriate programs and committees to examine the school board vacancies problems and come up with additional solutions.

Additionally, I would encourage consideration of staggered terms to proposed law changes for appropriate elected positions. The consideration of implementing limited terms on all political elective positions would provide the opportunity for the Nation to benefit from the varied perspective from our diverse Navajo Peoples' education, experience, and other leadership.

MEMBERS TO SERVE ON ONE SCHOOL BOARD

BE IT ENACTED:

Section 1. Findings

1. The Navajo Nation conducts elections for various elective positions, including elections for the various school boards within the Navajo Nation. 11 N.N.C. § 1 *et seq.*
2. Generally, for Navajo Nation and Chapter elections, the number of terms a person may serve in an elective position is unlimited "except as otherwise provided by law." 11 consecutive terms. 11 N.N.C. §6(D).
3. Further, school members are limited to serving on no more than one school board. 11 N.N.C. §8(D)(4)(k). Under Navajo law, school boards must represent children based on their chapter affiliation. It is possible for multiple schools to have children from the various different chapters. See the 2007 Local Community School Board Apportionment Plan, ECJA-01-08. Consequently, the law permits representation of a chapter on more than one school board. Consistent with due process, chapters should be permitted to elect school board members of their choice.
4. Since the Navajo Election Code of 1990 was enacted, the Navajo Election Administration has experienced more vacancies for school board positions than any other elective position. This has caused quorum problems for school boards.

5. It is in the best interest of the Navajo Nation to remove term limits for school board positions and to further authorize school board members to serve on one board.

Section 2. Title 11 Amendment

The Navajo Nation hereby amends 11 N.N.C. §§6 and 8 as follows:

**Chapter 1. Navajo Election Code of 1990
Subchapter 1. General Provisions**

§6. Terms of office; oath

C. Candidates elected to office in chapter elections shall be installed in office upon taking the oath of office, which shall be administered at the direction of the Board during the first week following the first Saturday in January, and their predecessors term of office shall expire upon their installation.

D. Local Community School Board members shall serve only four consecutive terms, inclusive of present terms. The school board member must not have a conflict of interest arising from any tribal, state or federal laws regarding his or her employment, including being an employee of the Navajo Nation Elections Administration or a member of the Navajo Nation Board of Election Supervisors.

§8. Qualifications for office

D. Qualifications for Other Elected Officials

4. Qualifications for Candidates for School Board:

k. If elected or appointed, the candidate shall serve on no more than one Local Community School Board.

Section 3. Effective date

The amendment enacted herein shall become effective in accord with 2 N.N.C. §2212(B).

Section 4. Codification


The amendments of the Navajo Nation Code enacted herein shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel shall include the amendment in the next recodification or supplement of the Navajo Nation Code to the extent practicable.

Section 5. Savings Clause

Should any portion of the amendments enacted herein be determined invalid by the Navajo Nation Supreme Court, or the District Courts of the Navajo Nation without appeal to the Navajo Nation Supreme Court, those portions not determined invalid shall remain the law of the Navajo Nation.
