# RESOLUTION OF THE NAVAJO NATION COUNCIL <br> $24^{\text {th }}$ NAVAJO NATION COUNCIL -- First Year, 2019 

AN ACTION RELATING 'TO NAABIK' ÍYÁTI' AND NAVAJO NATION COUNCIL; OVERRIDING THE NAVAJO NATION PRESIDENT'S VETO OF NAVAJO NATION COUNCIL RESOLUTION CO-38-19

## BE IT ENACTED:

## SECTION ONE. AUTHORITY

A. The Navajo Nation Council enacts laws of the Navajo Nation. 2 N.N.C. § 102.
B. All resolutions enacting new law or amending existing laws are subject to veto by the President of the Navajo Nation pursuant to 2 N.N.C. § $1005(C)(10)$ and (11) and override by the Navajo Nation Council. 2 N.N.C. § $164(\mathrm{~A})(17)$.
C. A vetoed resolution must first be submitted to Naabik'iyáti' Committee before consideration by the Navajo Nation Council. 2 N.N.C. § 164 (A) (17).
D. Legislation vetoed by the President of the Navajo Nation is subject to override "by two-thirds (2/3) vote of the membership of the Navajo Nation Council." 2 N.N.C. § 1005 (C) (11).

## SECTION TWO. FINDINGS

A. Resolution $C O-38-19$ was passed by the Navajo Nation Council on October 23, 2019. The resolution is entitled, " AN ACT RELATING TO LAW AND ORDER, NAABIK'IYATI' AND THE NAVAJO NATION COUNCIL; AMENDING, FOR PURPOSES OF CLARIFICATION, APPOINTMENT AND SPECIAL ELECTION PROVISIONS OF THE NAVAJO ELECTION CODE AT 11 N.N.C. §§ 143, 161 AND 326."
B. The changes enacted by the Navajo Nation Council through CO-38-19 merely clarify when appointments are made for purposes of filling vacant positions under the Navajo Election Code. The President vetoed the legislation, stating that voting rights are affected. See attached Exhibit "A," veto letter and resolution CO-38-19.
C. However, the intent and purposes of the original provisions of the Code remain the same - special elections are conducted to fill vacancies occurring in the first half of an elected term, and vacancies occurring in the second half are filled by appointment. The amendments of CO-38-19 provide that any vacancy continuing into the second half of a term is filled by appointment. As the intent and purpose of the law essentially remains the same, an override is necessary.
D. The Navajo Nation President's veto is "subject to an override...by two-thirds (2/3) vote of the membership of the Navajo Nation Council." 2 N.N.C. § 164 (A) (17).
E. The Navajo Nation Council finds it in the best interest of the Navajo Nation to override the Presidential veto herein.

## SECTION THREE. OVERRTDING VETO

The Navajo Nation Council hereby overrides the Navajo Nation President's veto of Resolution CO-38-19.

Dear Speaker Damon,
Pursuant to the authority vested in the Navajo Nation President. I am vetoing CO-38-19.
The resolution appears to be based on good intentions but in a closer look it takes away the right of the People to choose their leaders. The absence of legislative intent language in the resolution and based on an unsigned Navajo Board of Election Supervisors resolution with minimal reasoning is cause for concern as to the purpose of the amending language. The Election Code, as currently enacted prior to the amendments, allows for vacancies in the first half of a term of office to be filled by a special election. This special election process allows the People to make their choice of leader, a choice we should not take from them.

Absent specific clarification as to the purpose of $\mathrm{CO}-38-19$ and guarding the right of the Pcople to choose their leaders I am vetoing CO-38-19.

#### Abstract

RELATING TO LAW AND ORDER, NAABIK'IYÁTI' AND THE NAVAJO NATION COUNCIL; AMENDING, FOR PURPOSES OF CLARIFICATION, APPOINTMENT AND SPECIAL ELECTION PROVISIONS OF THE NAVAJO ELECTION CODE AT 11 N.N.C. §§ 143, 161 AND 326


BE IT ENACTED:

## SECTION ONE. AUTHORITY

A. The Law and Order Committee is a standing committee of the Navajo Nation Council with duthority to "review and make recommendations $L o$ the Navajo Nation Council on proposed amendments to and enactments in the Navajo Nation Code." 2 N.N.C. § $601(B)(14)$.
B. The Naabik'iyati' Committee of the Navajo Nation Council is a standing committee of the Navajo Nation Council. All proposed resolutions requiring final action by the Navajo Nation Council must be "assigned to standing committee(s) having authority over the subject matter at issue and the Naabik'iyati' Committee." 2 N.N.C. § $164(\mathrm{~A})(9)$.
C. The Navajo Nation Council is the lawmaking body of the Navajo Nation. 2 N.N.C. S 102.

SECTION TWO. FINDINGS
A. Concerning vacancies in Navajo Nation elective positions, those occurring within the first half of an elective term are filled by special election and those occurring within the second half by appointment. See e.q., 11 N.N.C. SS 143 and 161.
B. The Election Code must be amended tor clarification purposas to provide that vacancies occurring in the first half of an
elective position and continuing into the second half can be filled by appointment provisions of the code.
C. The Navajo Board of Election Supervisors recommends amending the Election Code to clarify appointments for vacancies within the second half of an elective term. See Exhibit "A."

## SECTION THREE. AMENDING ELECTION CODE

The Navajo Nation hereby amends the Navajo Election Code as follows:

## Subchapter 9. Special Elections

## § 143. Special Elections for vacancies during first half of term

Whenever a varancy is declared for an elected office during the first half of a term of office, with the exception of a vacancy involving the office of the Navajo Nation President or the Navajo Nation Vice President, the remaining term of the vacant office shall be filled pursuant to special election provisions of this Code. Except for vacancies for which a candidate or candidates have been deemed eligible by the Election Administration, vacancies derlared in the first half but continuing into the second half of an elective term shall be filled by appointment provisions of the Ellection Code.

## Subchaptex 10. Appointments

## § 161. Appointments

## Subchapter 17. Election Officials

## § 326. Vacancies within second half of term of office

A. Subject to 11 N.N.C. S 143 , A a vacancy occurring on the Board of Election Supervisors within the second half of a term of office shall be filled by appointment by majority vote of the Agency Council for the agency within which the vacancy exists. The selection shall be made from recommendations by the chapters within the agency affected, in the form of duly adopted Chapter resolutions. Each Chapter may recommend one candidate for appointment. The Agency Council shall review the candidates tor appointment and shall make its determination out of those recommended. The person appointed to fill any such vacancy must be a registered voter of a Chapter from within the same agency of his or her predecessor, and shall serve until the normal expiration date of the term he or she has filled.

## SECTION FIVE. CODIFICATION

The amendments ut the Navajo Nation Code enacted herein shall be codified by the office of legislative counsel. The office of Iegislative Counsel shall include the amendment in the next recodification or supplement of the Navajo Nation Code, to the extent practicable.
